According to the Company's knowledge, none of the members of the Management Board of Comarch SA conducts no competitive activities in relation to the activity of Comarch SA, does not function as supervisory or management bodies of companies which declared bankruptcy during his term of office, it is not entered in the Register of Insolvent Debtors maintained on the basis of the National Court Register Act.

Janusz Filipiak is the founder and CEO of Comarch SA. He holds a Professor's degree in telecommunications, which enables him to give his organization unique competitive features from functioning on the convergence of the academic and business worlds.
