Acting in accordance with Article 69 of the Act of the 29th of July, 2005 on Public Offering and the Conditions Governing the Introduction of Financial Instruments to Organized Trading and on Public Companies (Journal of Laws of 2022, item 2554) - (hereinafter referred to as the "Act"), Generali Powszchne Towarzystwo Emerytalne S.A. (the Society) with its registered office in Warsaw, at Senatorska Street 18, informs that on the 21st of July, 2023, the liquidation of NNLife Otwarty Fundusz Emerytalny (hereinafter referred to as the "NNLife OFE") was completed. On the date of completion of the liquidation of NNLife OFE, its assets were transferred to Generali Otwarty Fundusz Emerytalny (open pension fund, hereinafter referred to as "Generali OFE"), therefore Generali OFE's share in the share capital and in the total number of votes of Comarch S.A. (hereinafter referred to as the "Company") exceeded the 5% threshold.

Before the liquidation of NNLife OFE (NNLife open pension fund)

In total, Generali OFE and NNLife OFE held 829,183 (in words: eight hundred and twenty-nine thousand one hundred and eighty-three) shares, which constituted 10.19% of the share capital of the Company and 829,183 (in words: eight hundred and twenty-nine thousand one hundred and eighty-three) votes at the General Meeting of Shareholders of the Company, which constituted 5.48% of the total number of votes;

Of this, Generali OFE held 57,229 (say: fifty seven thousand two hundred and twenty nine) shares, which constituted 0.70% of the share capital of the Company and 57,229 (say: fifty seven thousand two hundred and twenty nine) votes at the General Meeting of Shareholders of the Company, which constituted 0.38% of the total number of votes;

After the liquidation of NNLife OFE (NNLife open pension fund)

Generali OFE hold a total of 829,183 (say: eight hundred and twenty-nine thousand, one hundred and eighty-three) shares, which constituted 10.19% of the share capital of the Company and 829,183 (say: eight hundred and twenty-nine thousand, one hundred and eighty-three) votes at the General Meeting of Shareholders of the Company, which constituted 5.48% of the total number votes;
