She obtained her doctoral degree in sociology in 1984 and habilitation in 1995, both conferred by the Council of the Faculty of Philosophy and History at Jagiellonian University. In 2002, she was awarded the title of Professor of Humanities by the President of the Republic of Poland. Since 2010, she has held the position of full professor at Jagiellonian University.
